

Privacy Policy

The Ogemaw Hills Snowmobile Club (“us”, “we”, or “our” “OHSC”) operates the ohsconline.com website (the “Service”).

This page informs you of our policies regarding the collection, use and disclosure of Personal Information when you use our Service.

We will not use, share, rent or sell your information with anyone except, internally, as described in this Privacy Policy.

Information Collection And Use

Voluntarily Submitted Personal Information
